GOP FUNDING BILL SHORTCHANGES AMERICA'S CHILDREN BY UNDERFUNDING KEY EDUCATION PRIORITIES

This week, Republicans will attempt to pass an appropriations bill that shortchanges many of the key promises made to parents and children in the bipartisan No Child Left Behind Act. Overall, the Labor/HHS bill underfunds the No Child Left Behind Act by \$8 billion, and provides the smallest percentage increase in education funds in eight years. Whether it's improving teacher training, demanding that all students make progress, funding after-school centers, or helping the children of military personnel, Republicans talk about accountability while failing to provide the necessary resources. Under the GOP budget, massive tax cuts have crowded out education priorities. As a result, the Republican Labor/HHS bill cuts education funding for America's children by a total of \$9.2 billion below the levels authorized by the No Child Left Behind Act and the IDEA Reauthorization Act, with key cuts highlighted below.
